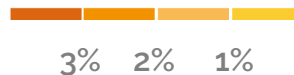

Governance a key priority in the reform agenda



Governance reform placed as Pillar 1 in the Mid-Term Review of the 11th Malaysia Plan.

Governance continues to be a key development priority in upcoming 12th Malaysia Plan.



21 of 60 commitments in Pakatan Harapan Manifesto related to good governance.

Local Government at the heart of the SDGs



- Governance reform thus far focused mainly at the national/federal level, and there is increasing recognition of the crucial role that state and local governments play in achieving and sustaining Malaysia's reform agenda.
- SDGs are not only about achieving the national averages but about ensuring that everybody enjoys the development gains.
- This makes state and local governments an *indispensable partner* – full and active engagement is needed to accelerate progress on the SDGs, including SDG 16 on peace, justice and strong institutions.

What are the **incentives** for 'localization'?



- **Leave no one behind and Leave no place behind**
- **Strengthened awareness and capacity development** of citizens, organizations and institutions for sustainable development
- **Access to development resources**
- **Involvement in the global community**
- **Aligned global, national and local political and economic frameworks**
- **'Sustainable Development Roadmap'** for mayors and local leaders for decentralized cooperation



How can the SDGs be localized **in cities**?

- **Initiate an inclusive and participatory process:** Raising awareness of the SDGs and engaging stakeholder collaboration to achieve the goals and targets.
- **Set the local SDG agenda:** Translating the global SDGs into an ambitious yet realistic agenda that is tailored to the local development context.
- **Plan for SDG implementation:** Pursuing goal-based planning principles and mechanisms for more sustainable social, economic and environmental outcomes.
- **Support capacity development and mobilize funding/resources:** Assessing institutional and organizational capacity and funding gaps
- **Monitor and evaluate:** Ensuring that SDG implementation remains on track, and developing local capacity for more responsive and accountable governance.

UNDP's work: SDGs localization + Subnational engagement



Governance

- Strengthening **local governance** through vertical assessments of planning and budgeting at subnational level.
- “All About SDGs” Campaign” partnering with **city councils across Malaysia** to promote awareness and implementation of SDGs among local communities in urban centres.

UNDP's work: **SDGs localization** **+ Subnational engagement**



Inclusive Development and Growth

- Collaborating with Iskandar Regional Development Authority to set up a centralized data analytics centre (Iskandar Malaysia Urban Observatory) to provide evidence-based policies for regional development. The project will engage with **5 local councils as well as state level agencies** on data management & coordination for improved urban service delivery in line with the SDGs.

UNDP's work: SDGs localization + Subnational engagement



Sustainable and Resilient Development

- Green Technology Application for the Development of Low Carbon Cities (GTALCC) project works with **9 local authorities in 5 urban centers (Putrajaya, Iskandar Malaysia, Cyberjaya, Petaling Jaya and Hang Tuah Jaya)** to implement sustainable city solutions, strengthen institutions and to improve policies and processes in city planning to urgently address the climate crisis.

+ Tools and resources



City Prosperity Initiative

- A platform for urban data collection, developed to formulate evidence based decision making and monitoring for cities, as a response to the demand of local authorities in need of a tool which measures the **prosperity and sustainability** of cities
- Successfully utilized by **over 400 cities** around the world.
- **6 dimensions** of CPI including urban governance; productivity; infrastructure development; quality of life; equality and social inclusion; and environmental sustainability.

Participatory Slum Upgrading Programme

- Generation of a **city-wide profile of informal settlements** which is community-led, participatory, coordinated by local or city government and helps mobilize citywide pooling of funds.
- Applying the **Social Tenure Domain Model** software and other related land tools to establish a learning hub and provide more accurate and better management of data.
- **Transferring expertise** to the communities themselves.

Mayors Academy for Sustainable Urbanization

- Provide capacity development programmes to local authorities' leaders to implement sustainable urban development and increase their leadership and technical capacities.
- Assist **newly-elected mayors** to become knowledgeable and committed to the global development agendas and the contributions of cities.
- Increase the use of sustainable urban development tools, resources and technical solutions by newly-elected mayors in the region; as well as **city-to-city cooperation** opportunities.
- Establish a regional network of informed mayors and local leaders.

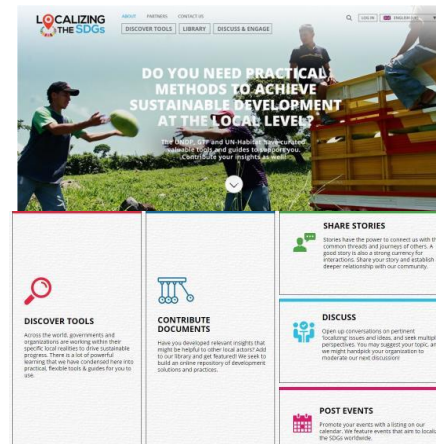
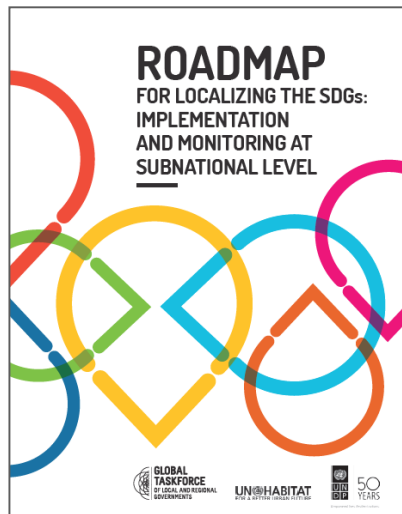
RECOMMENDATIONS



- Strengthen local budgeting through **fiscal decentralization**: reassign certain expenditure responsibilities from federal to state and local governments such as selected aspects of education, transport and enforcement.
- Enhance transparency and introduce **participatory budgeting** at state and local government levels.
- Strengthen local planning through increased **public engagement and community participation** in planning and decision-making processes
- Improve **horizontal** (between government agencies dealing with development planning and spatial planning) and **vertical interaction** (between state/local authorities on development issues).
- Encourage cities to undertake **Voluntary Local Reviews (VLRs)** of the SDGs.
- Develop a set of **localized indicators**, specific to the state or territory.
